(the actual field will be sign posted).** **Please note this is the same field as we used in 2014.** The run is planned to terminate at approx. 1700hrs. Trailer and vehicle access will be provided but the security of any vehicles left will be the owner's responsibility.

We do use public roads so please ensure that your machine is in a roadworthy condition, uses legal fuel and has the relevant Road Traffic Act Insurance, including third party public liability indemnity.

We ask that passengers are only permitted on tractors with factory fitted seats or in approved passenger carrying roadworthy trailers.
